<b>April 14, 2009</b>	Earliest day for a political body to begin circulating nomination petitions for state-wide candidates nominated by convention. O.C.G.A. 21-2-182
<b>January 1, 2010</b>	Earliest day to file and publish a notice of intention to be a write-in candidate in the November General/Nonpartisan Election. O.C.G.A. 21-2-133 (a)
<b>January 14, 2010</b>	Earliest day for an Independent or Political Body candidate to begin circulating a nomination petition for an office other than a Political Body candidate running for a state-wide office in which they are nominated by state-wide convention. O.C.G.A. 21-2-170 (e)
<b>February 16, 2010</b>	Last day for a person to register and be eligible to vote in the March Special Election. O.C.G.A. 21-2-224 (a)
<b>April 26, 2010</b>	Earliest day for a Political Party candidate to file Declaration of Candidacy to have their name placed on the July General Primary Ballot. O.C.G.A. 21-2-153 ( c ) (1)
<b>April 30, 2010 12:00 noon</b>	Last day for a Political Party candidate to file Declaration of Candidacy to have their name placed on the July General Primary Ballot. O.C.G.A. 21-2-153 (c ) (1)
<b>June 20, 2010</b>	Last day for a political body to hold a convention for the purpose of nominating candidates to be placed on the November General Election Ballot. O.C. G.A. 21-2-172 (e)
<b>June 21, 2010</b>	Last day for a person to register and be eligible to vote in the July General Primary/Special Election. O.C.G.A. 21-2-224 (a)
<b>June 28, 2010 9:00 a.m.</b>	Earliest day for an Independent or Political Body candidate to file a nomination petition. O.C.G.A. 21-2-132 (d)
<b>June 28, 2010 9:00 a.m.</b>	Earliest day for an Independent, Political Body, or Nonpartisan candidate to file Notice of Candidacy to have their name placed on the November General Election Ballot. O.C.G.A. 21-2-132 (c ) (1) (2)
<b>July 2, 2010 12:00 noon</b>	Last day for Independent, Political Body, or Nonpartisan candidate to file Notice of Candidacy to have their named placed on the November General Election Ballot. O.C.G.A. 21-2-132 (c) (1)(2)
<b>July 13, 2010 12:00 noon</b>	Last day for an Independent or a Political body candidate to file the required nomination petition. O.C.G.A. 21-2-132 (d);21-2-187
<b>July 13, 2010 12:00 noon</b>	Last day for a political body desiring to nominate its statewide candidates by convention to file a qualifying petition. O.C.G.A. 21-2-187
<b>August 23, 2010</b>	Last day for a person to register and be eligible to vote in the September Special Election. O.C.G.A. 21-2-224 (a)
<b>September 7, 2010</b>	Last day to file and publish a notice of intention to be a write-in candidate in the November General/Nonpartisan/Special Election O.C.G.A. 21-2-133 (a)
<b>September 13, 2010</b>	Last day to file affidavit stating the notice of intention to be a write-in candidate has been published in accordance with O.C.G.A. 21-2-133 (b)
<b>October 4, 2010</b>	Last day a person may register and be eligible to vote in the November General/Nonpartisan/Special Election and Runoff O.C.G.A. 21-2-224 (a)
