The Whitfield County Board of Commissioners will receive sealed RFP's until 2:00 PM on **4-25-2024** for **RFP#FD24-001**, Epoxy Flake Flooring System Stations 2-5.

Project Scope: Whitfield County is looking for qualified vendors to complete an Epoxy Flake Floor system at Four Fire Stations. Whitfield County will be responsible for the removal of all Furniture, existing flooring and cove base. Approx. 1000 Sq. Ft. per station.

PROPOSED SCOPE OF WORK:

System:

Laminin Industrial Coatings Flooring System with Laminin ¼” Broadcast Flakes

Process:

1. Profile entire floor by grinding with 30 grit impregnated diamonds
2. After Grinding, Prime Floor with Laminin Colossal 117 – EPS
3. Once Dry, trowel apply Laminin Colossal – 117 USL and Broadcast ¼ inch flake
4. Once Cured, Scrape and Vacuum excess flakes and Apply Laminin Top Coat
5. Replace existing Cove Base with new vinyl cove base molding
